

## GUIDE TO VISA TO VIET NAM

All delegates are required to possess a valid passport in order to enter Viet Nam. Delegates from certain countries may require a visa for entry. It is the responsibility of the delegates/delegations to arrange for visas, if applicable.

### 1. Visa exemption:

In order to facilitate entry into Viet Nam under the visa exemption policy, delegations and foreign nationals must fulfill the following conditions:

- Possess a valid passport issued by the relevant authority of their country of nationality, with at least six months of validity remaining from the intended date of entry.
- Hold a return or onward ticket to another country.
- Not be subject to any restrictions on entry or exit as stipulated in Articles 21 and 28 of the Law on Entry, Exit, Transit, and Residence of Foreigners in Viet Nam.

### 2. Visa application:

**\* For Members of delegations invited by the Prime Minister or the Deputy Prime Minister, Minister of Foreign Affairs of Viet Nam, and P4G Summit Organizing Committee:**

**- For Delegations/Delegates from Countries with a Diplomatic Mission in Viet Nam:**  
The delegation/delegate must submit a dossier through the Diplomatic Mission in Viet Nam, or the Representative Offices of United Nations Specialized Agencies in Viet Nam to the Consular Department: to obtain a Diplomatic Note with a visa approval number. This Diplomatic Note can be used to acquire a visa on arrival at Viet Nam's border gates or at Vietnamese diplomatic missions abroad.

**- For Delegations/Delegates from countries without a Diplomatic Mission in Viet Nam or in case their Diplomatic Missions in Viet Nam do not support the visa procedures:** The delegation/delegate should apply through Vietnamese diplomatic missions abroad (including missions accredited to the respective country) to obtain a visa approval number.

#### **Dossier Requirements:**

- A diplomatic note from the foreign diplomatic mission in Viet Nam or from the Ministry of Foreign Affairs of the sending country (if no diplomatic mission exists in Viet Nam).
- A form with a QR code (available at: [visa.mofa.gov.vn](https://visa.mofa.gov.vn)).
- A copy of the passport of the visa applicant.
- A copy of the invitation letter.

#### **\* Note:**

- The granting of this visa does not imply or guarantee entry. The immigration authorities at the port of entry have the right to deny admission.
- Delegations/delegates can choose to obtain visas either at Vietnamese diplomatic missions abroad or visas on arrival at Viet Nam's border gates, as indicated in the diplomatic note or specified in the form.
